
1 WHEREAS, The following named persons have formally relinquished their


7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does

13 day of January, 1987, at a meeting at which a quorum was present with a vote
14 of 1354.0 for; 169.0 against; -0- not voting; and 117.0 absent, pursuant to the
15 powers vested in the Council by Section 3 of Article II and Article VI Section
16 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
17 O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
19 16 of the Act of June 18, 1934 (48 Stat. 984).
