2	limited health care fiscal resources through a standard consistently
3	applied, allocation methodology; and
4	WHEREAS, the Indian Health Service is in the process of incrementally
5	introducing revision of the historical allocation methodology called
6	Area Resource Allocation Methodology (ARAM)/Service Unit Resource
7	
8	Allocation Methodology (SURAM); and
9	WHEREAS, the Indian Health Service has established task groups to address key
10	areas of Tribal concern in the ARAM/SURAM methodology; and
11	WHEREAS, staff of the Tohono O'Odham Health Department did participate on such
12 13	Task Group addressing the consideration of alternative resources and
13	contributed to the authorship of a Study Report and Recommendation;

16	WHEREAS, the Tohono O'Odham Nation feels strongly that only Medicare be
17	considered an alternate resource when determining the IHS allocation
18	to Service Units or Tribal Operations; and
19	WHEREAS, the Tohono O'Odham Health and Human Services Legislative Committee has
20	reviewed this Discussion Paper and recommends to the Tohono O'Odham
21	Legislative Council to seek endorsement from the National Congress of
22	American Indians (NCAI).
23 24	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
25	endorse this resolution and encourages IHS adoption of the
26	recommendations developed by the Alternate Resources Task Group in
27	Seattle during August 1987.
