

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Supporting proposed August 7, 1987 Draft amendments to the  
Indian Self-Determination & Education Assistance Act)

RES. NO. 321-87

1 WHEREAS, the Tohono O'Odham Nation does recognize and affirm its right to  
2 Self-Determination; and

3 WHEREAS, the Tohono O'Odham Nation may elect to exercise the opportunities  
4 inherent to Public Law 93-638 in achieving Self-Determination; and

5 WHEREAS, the Tohono O'Odham Nation recognizes the need to amend the existing  
6 law to simplify and expedite the contracting process and related  
7 management and administrative procedure under said law; and


8 WHEREAS, the Tohono O'Odham Nation concurs substantially with the amendments as  
9 proposed; and

10 WHEREAS, the Tohono O'Odham Health and Human Services Legislative Committee has  
11 reviewed the amendments and recommends to the Tohono O'Odham  
12 Legislative Council to seek endorsement from the National Congress of  
13 American Indians (NCAI).

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does  
15 endorse this resolution for the adoption of the proposed amendments to  
16 the Indian Self-Determination and Education Assistance Act and seeks  
17 the support of the National Congress of American Indians on this  
18 matter.

19 The foregoing resolution was passed by the Tohono O'odham Council on the 15th  
20 day of September, 1987, at a meeting at which a quorum was present with a vote  
21 of 1523.0 for; 58.5 against; 58.5 not voting; and -0- absent, pursuant to the  
22 powers vested in the Council by Section 1 (c)(2) of Article VI of the Constitu-  
23 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
24 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
26 of June 18, 1934 (48 Stat. 984).
