

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Economic Development)

RES. NO. 323-87

1 WHEREAS, Senator Daniel K. Inouye (D-Hawaii) and Representative Bill Richardson
2 (D-New Mexico) have introduced bills, S 721 and HR 2455, to create a
3 financial institution to assist Indian-owned business enterprises with
4 capital, financial services and technical assistance; and

5 WHEREAS, the Administration for Native American (ANA) funds economic
6 development projects; and


7 WHEREAS, these efforts to recognize tribal economic development needs are
8 viewed as a step in the right direction for tribes to achieve economic
9 self-sufficiency.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
11 it hereby seeks the support and reinforcement on behalf of the San
12 Xavier District, the Tohono O'Odham Nation, and American Indians and
13 Alaska Natives to the 44th Annual National Congress of American
14 Indians in Tampa, Florida to recognize these positive efforts on
15 behalf of Indian Tribes.

16 BE IT FURTHER RESOLVED that the Official Delegate of the Tohono O'odham Nation
17 to the Nation Congress of American Indians is hereby authorized and
18 directed to do everything necessary to implement the purposes of this
19 resolution.


20 The foregoing resolution was passed by the Tohono O'odham Council on the 15th
21 day of September, 1987, at a meeting at which a quorum was present with a vote
22 of 1,597.5 for; -0- against; 42.5 not voting; and 01 absent, pursuant to the
23 powers vested in the Council by Section 1 (d)(2) of Article VI of the Consti-
24 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
25 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).


