1	WHEREAS, Senator John Melcher (D-Mont.) and Representative Ron Marlenee
2	(D-Mont.) have introduced bills (HB 2185 and SB 1139) limiting tribal
3	taxation authority by imposing a moratorium on approval of tribal tax
4	ordinances by the Secretary of the Interior and defining certain tax
5	regulations for tribes; and
6	WHEREAS, the Constitution of the Tohono O'Odham Nation, Article VI, Section 1
7	(d)(4) defines the power of the Nation to levy taxes on "any
8	person, corporation, or association residing or doing business
9	within the Tohono O'Odham Nation", and
10	WHEREAS, the San Xavier District is directly affected by having a non-Indian
11 12	community within the boundaries of the Tohono O'Odham Nation's San
12	Xavier District who are paying <u>no taxes</u> to the Nation or the District
14	and
15	WHEREAS, the San Xavier District Council strongly opposes limitation of a
16	tribe's power to tax and concurs with the statement on these bills by
17	
18	the Montana Indian Tribes that " the right to tax is a necessary
19	attribute of self government, of sovereignty"
20	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
21	it hereby seeks the support and reinforcement on behalf of the San
22	Xavier District, the Tohono O'Odham Nation, and American Indians and
23	Alaska Natives to the 44th Annual Congress of American Indians in
24	Tampa, Florida to strongly affirm tribal taxation rights and lobby to
25 26	defeat the Melcher/Marlenee Bills.
26 27	BE IT FURTHER RESOLVED the the Official Delegate of the Tohono O'odham Nation
27	to the National Congress of American Indians is hereby authorized and
29	directed to do everything necessary to implement the purposes of this
