| 11 | NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that |
| 12 | it hereby seeks the support and reinforcement on behalf of the San |
| 13 | Xavier District, the Tohono O'Odham Nation, and American Indians and |
| 14 | Alaska Natives to the 44th Annual Congress of American Indians in |
| 15 | Tampa, Florida to defeat the Gaming Bills and seek alternative metho |
| 16 | to insure tribal rights and jurisdiction over gaming operations. |
| 17 | BE IT FURTHER RESOLVED that the Official Delegate of the Tohono O'odham Natio |
| 18 | DE 11 FORTHER RESOLVED CHAC CHE OTTTETAT Delegate of the Tolloho o ballam Natto |

Nation to the National Congress of American Indians is hereby authorized and directed to do everything necessary to implement the purposes of this resolution.

The foregoing resolution was passed by the Tohono O'odham Council on the 15th day of September, 1987, at a meeting at which a quorum was present with a vote of $\underline{1,597.5}$ for; $\underline{-0}$ against; $\underline{42.5}$ not voting; and $\underline{01}$ absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
