16	forthwith to forgive all debt to Indian Housing Authorities on old						
17	Mutual Help projects and to establish a committee to develop proper						
18	regulations therefor as requested by the National American Indian

20	BE IT FURTHER RESOLVED that the Official Delegate of the Tohono O'odham Nation						
21	to the National Congress of American Indians is hereby authorized and

28	January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Ac						
29	of June 18, 1934 (48 Stat. 984).
