

RESOLUTION OF THE TOHONO O'ODHAM COUNCIL
(Supporting National American Indian Housing Council
Conversion of Low Rental Units to Mutual Help; Resolution No. 87-12)

RES. NO. 327-87

1 WHEREAS, the National American Indian Housing Council did by Resolution No.
2 87-12 request the Department of Housing and Urban Development to
3 develop guidelines for the conversion of low income Rental Units to
4 Mutual Help units at the earliest possible date; and
5
6 WHEREAS, the Tohono O'odham Housing Authority and the Housing Committee of the
7 Legislative Council have reviewed the request and have voiced their
8 support thereof; and

10 WHEREAS, the Tohono O'odham Legislative Council has determined that it would be
11 in the best interest of the Tohono O'odham Nation and of Indian tribes
12 generally, if Indian housing authorities had the authority and ability
13 of converting low-income Rental units to Mutual Help units.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
16 supports the National American Indian Housing Council in its
17 Resolution No. 87-12, and requests the Department of Housing and Urban
18 Development forthwith to develop guidelines for the conversion of
19 low-income Rental units to Mutual Help units.

21 BE IT FURTHER RESOLVED that the Official Delegate of the Tohono O'odham Nation
22 to the National Congress of American Indians is hereby authorized and
23 directed to do everything necessary to implement the purposes of this
24 resolution.

24 The foregoing resolution was passed by the Tohono O'odham Council on the 15th
25 day of September, 1987, at a meeting at which a quorum was present with a vote
26 of 1,640.0 for; -0- against; -0- not voting; and 02 absent, pursuant to the
27 powers vested in the Council by Section 1 (j) of Article VI of the Constitu-
28 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
29 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
30 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
31 of June 18, 1934 (48 Stat. 984).
