WHEREAS, the National American Indian Housing Council did by Resolution No.

2	87-12 request the Department of Housing and Urban Development to
3	develop guidelines for the conversion of low income Rental Units to
4	Mutual Help units at the earliest possible date; and

6	WHEREAS, the Tohono O'odham Housing Authority and the Housing Committee of the
7	Legislative Council have reviewed the request and have voiced their
8	support thereof; and
9	WHEREAS, the Tohono O'odham Legislative Council has determined that it would be
10	in the best interest of the Tohono O'odham Nation and of Indian tribes
11	generally, if Indian housing authorities had the authority and ability
12	of converting low-income Rental units to Mutual Help units.
13	
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
15	supports the National American Indian Housing Council in its
16	Resolution No. 87-12, and requests the Department of Housing and Urban
17	Development forthwith to develop guidelines for the conversion of
18	low-income Rental units to Mutual Help units.
19	BE IT FURTHER RESOLVED that the Official Delegate of the Tohono O'odham Nation
20	to the National Congress of American Indians is hereby authorized and
21	directed to do everything necessary to implement the purposes of this
22	resolution.

24	The foregoing resolution was passed by the Tohono O'odham Council on the <u>15th</u> day of September, 1987, at a meeting at which a quorum was present with a vote
25	of $1,640.0$ for; $-0$ - against; $-0$ - not voting; and $02$ absent, pursuant to the powers vested in the Council by Section 1 (j) of Article VI of the Constitu-
26	tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
27	January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Ac
28	of June 18, 1934 (48 Stat. 984).
