13	WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the En-

15	rollment Committee and approves thereof.
16	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that, subject to
17	the approval of the Secretary of the Interior, the names of the
