

RESOLUTION OF THE TOHONO O'ODHAM COUNCIL
(Supporting National American Indian Housing Council Housing Deductions
and Rental Ceiling; Resolution No. 87-13)

RES. NO. 328-87

1 WHEREAS, the National American Indian Housing Council has by Resolution No.
2 87-13 recommended that certain deductions be re-established for
3 Department of Housing and Urban Development Rental, Mutual Help and
4 Turnkey III program participants; and

6 WHEREAS, the Tohono O'odham Housing Authority and the Housing Committee of the
7 Legislative Council believe that the current method of calculating
8 rent and homebuyer payments unfairly penalizes certain enterprising
9 program participants and therefore concur in the recommendation
10 contained in Resolution No. 87-13.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it
12 supports the recommendations contained in Resolution No. 87-13 of the
13 National American Indian Housing Council and does hereby call upon the
14 Department of Housing and Urban Development to establish the therein
15 proposed deductions for Rental, Mutual Help and Turnkey program
16 participants.

18 BE IT FURTHER RESOLVED that the Official Delegate of the Tohono O'odham Nation
19 to the National Congress of the American Indians is hereby authorized
20 and directed to do everything necessary to implement the purposes of
21 this resolution.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 15th
24 day of September, 1987, at a meeting at which a quorum was present with a vote
25 of 1,640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the
26 powers vested in the Council by Section 1 (j) of Article VI of the Constitu-
27 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
