1	WHEREAS,	the National American Indian Housing Council did, by Resolution No.
2		87-2, recommend that a nine member committee composed of a
3		representative from each of the nine member regions of the Council be
4		
5		authorized and directed to work with the Census Bureau in order to
6		develop a better methodology for identifying and counting Indians in
7		the forthcoming 1990 Census; and
8	WHEREAS,	the Housing Committee of the Legislative Council has reviewed and
9		concurred in this recommendation, and has determined that the census
10		methodology used in prior counts, particularly the 1980 Census, was
11		flawed and resulted in a substantial population undercount of the
12		Tohono O'odham Nation, and needs to be improved.
13		Tollotto o dariam Nactori, and needs to be improved.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it supports the establishment of a nine member committee of the National American Indian Housing Council to work with the Census Bureau in order to develop a better methodology for identifying and counting Indians in the 1990 Census.

BE IT FURTHER RESOLVED that the Official Delegate of the Tohono O'odham Nation to the National Congress of American Indians is hereby authorized and directed to do everything necessary to implement the purposes of this resolution.

The foregoing resolution was passed by the Tohono O'odham Council on the $\underline{15th}$ day of September, 1987, at a meeting at which a quorum was present with a vote of $\underline{1,640.0}$ for; $\underline{-0}$ against; $\underline{-0}$ not voting; and $\underline{01}$ absent, pursuant to the powers vested in the Council by Section 1 (j) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
