

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Health Care)

RES. NO. 334-87

1 WHEREAS, the San Xavier District of the Tohono O'Odham Nation views the health
2 and well being of its community members as one of the primary areas of
3 concerns; and

4 WHEREAS, the Indian Health Service is currently the primary provider of health
5 care delivery, and that these services by the United States Government
6 is a trust responsibility; and

7 WHEREAS, at the current time the State of Arizona and the united States
8 Government (through the Indian Health Service) are at odds over
9 provision of health services to AHCCSS eligible O'Odham as well as
10 other tribes; and


11 WHEREAS, the Congress of the United States should restore Indian Health Service
12 funding to a level where the Indian Health Service can provide
13 adequate and quality health care services.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
16 it hereby seeks the support and reinforcement on behalf of the San
17 Xavier District, the Tohono O'Odham Nation, and American Indians and
18 Alaska Natives to the 44th National Congress of American Indians in
19 Tampa, Florida to provide health care services at the highest possible
20 level through the United States Government (Indian Health Service) and
21 the right of our people and all tribes to receive services for which
22 they are eligible through the States.


24 BE IT FURTHER RESOLVED that the Official Delegate of the Tohono O'odham Nation
25 to the National Congress of American Indians is hereby authorized and
26 directed to do everything necessary to implement the purposes of this
27 resolution.

The foregoing resolution was passed by the Tohono O'odham Council on the 15th day of September, 1987, at a meeting at which a quorum was present with a vote of 1,555.0 for; -0- against; -0- not voting; and 85.0 absent, pursuant to the powers vested in the Council by Section 1 (c)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
