## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Endorsing Section 904 of S. 1665; The Farm Credit Act)

RES. NO. 335-87

WHEREAS, Senator John Melcher has submitted to Indian tribes for review and comment section 904 of S. 1665, the Farm Credit Act of 1987, which will protect reservation land interests which are foreclosed by the Farmer's Home Administration by guaranteeing the right of first purchase of foreclosed land interests to the Indian borrower, his family, other tribal members or the tribe, and by providing that, if not so purchased, the foreclosed land interests shall be held in trust, respectively by the Secretaries of Agriculture and the 9 Interior, until such time as tribal members or the tribe are able to reacquire such interests; and 12

WHEREAS, section 904 of S. 1665 classifies the Congressional intent, protects reservation lands from possible purchase and encroachment by non-Indians; and serves the interests of Indian borrowers, their families and tribes.

NOW, THEREFORE, BE IT RESOLVED by the Council that the Tohono O'odham Nation strongly supports the provisions of section 904 of S. 1665 and directs that the appropriate officers of the Council and Nation to so advise Senators John Melcher, Dennis DeConcini and John McCain as well as the Subcommittee on Agricultural Credit.

BE IT FURTHER RESOLVED that the Official Delegate to the National Congress of American Indians is hereby authorized and directed to do everything necessary to implement the purposes of this resolution.

The foregoing resolution was passed by the Tohono O'odham Council on the 15th day of September, 1987, at a meeting at which a quorum was present with a vote of 1,514.0 for; -0- against; 126.0 not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1 (j) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
