

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amendment to the Judicial Services Contract)

RES. NO. 336-87

1 WHEREAS, the Tohono O'odham Legislative Council did pass Resolution No. 295-87
2 to amend the Judicial Services Contract to incorporate unspent funds
3 of \$47,000.00 for use by the Advocate Program; and

4 WHEREAS, an additional \$3,000.00 of unspent funds has been identified by the
5 Bureau of Indian Affairs; and

6 WHEREAS, any amendments affecting the funding or funding levels of the contract
7 shall be submitted for review and approval by the Tohono O'odham
8 Legislative Council; and

9 WHEREAS, an amendment has been submitted for review and approval.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does
11 approve this amendment to the Judicial Services Contract and authorize
12 expenditures in accordance with the attached budget.

14 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the
15 Chairman, Vice Chairman and Treasurer of the Tohono O'odham Nation are
16 hereby authorized to negotiate and execute these contracts and any
17 amendments affecting the funding or funding levels of this contract
18 shall be submitted for further prior approval by this Council.

20 The foregoing resolution was passed by the Tohono O'odham Council on the 15th
21 day of September, 1987, at a meeting at which a quorum was present with a vote
22 of 1,640.0 for; -0- against; -0- not voting; and 03 absent, pursuant to the
23 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-
24 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
