WHEREAS, an application for enrollment as a member of the Tohono O'odham Nation has been filed by or on behalf of CHRISTOPHER JOSEPH COOK "applicant"; and

WHEREAS, The Enrollment Committee has reviewed the application and has recommended that the application be denied because the applicant failed to establish the following membership requirement(s): TOHONO O'ODHAM CONSTITUTION, ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

WHEREAS, The application has come on for hearing before this Council; and

WHEREAS, The Enrollment Committee did serve written notice of its recommendation to reject the application and of this hearing, as required by Section 2, Article VI of the Enrollment Ordinance, upon the person who filed the application and such person was not present at this hearing; and

WHEREAS, The Tohono O'odham Council has reviewed all of the evidence presented and from such evidence finds that the applicant has failed to establish the foregoing membership requirement(s).

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does hereby determine that the application of CHRISTOPHER JOSEPH COOK for enrollment as a member of the Tohono O'odham Nation is hereby rejected.

BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions of Section 1 and 2, Article VIII of of the Enrollment Ordinance.

The foregoing resolution was defeated by the Tohono O'odham Council on the 29th day of September, 1987, at a meeting at which a quorum was present with a vote of 257.0 for; 774.5 against; 608.5 not voting; and 01 absent, pursuant to the powers vested in the Council by Article II and Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
