(Approve Enrollment Application for Christopher J. Cook)

1 WHEREAS, the Tohono O'odham Council has reviewed the application for enrollment
2 by CHRISTOPHER J. COOK; and

3 WHEREAS, such application does meet the requirement of Section I of Article
4 VIII of the Enrollment Ordinance No. 5-81; and

5 WHEREAS, the Tohono O'odham Legislative Council has made a final determination
6 that the application of CHRISTOPHER J. COOK for membership in the
7 Tohono O'odham Nation be approved under Article II MEMBERSHIP Section
8 1(b) "All children born to resident members."

11 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above-
12 named applicant is eligible for enrollment as a member of the Tohono
13 O'odham Nation under Section 1b of Article II of the Tohono O'odham
14 Nation, and his application is approved, as herein above indicated.

15 BE IT FURTHER RESOLVED that the Chairman to the appropriate officers of the
16 Tohono O'odham Nation reduce this final determination in writing
17 regarding the foregoing application for enrollment in accordance with
18 Section 3(c) of Article III of the Enrollment Ordinance; give notice
19 of this Council's determination in accordance with Section 4 of
20 Article III of the Enrollment Ordinance; and place the name of
21 Christopher Cook upon the membership roll of the Tohono O'odham Nation
22 in accordance with Article V of the Enrollment Ordinance.

24 The foregoing resolution was passed by the Tohono O'odham Council on the 29th
25 day of September, 1987, at a meeting at which a quorum was present with a vote
26 of 960.5 for; -0- against; 679.5 not voting; and 01 absent, pursuant to the
27 powers vested in the Council by Section 1 (h) of Article VI of the Constitu-
28 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
29 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
30 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
31 of June 18, 1934 (48 Stat. 984).
