WHEREAS, Cecilia Hernandez did testify that she should be given a district regional reference by reason of descent from an ancestor on the base roll and that they do intend and consider the Tohono O'odham Nation their permanent home.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the enrollment number of Cecilia Hernandez (Galvez) be amended to reflect a regional reference of CK, including her children.

BE IT FURTHER RESOLVED that it is hereby determined that the above-named applicants are eligible for enrollment as members of the Tohono O'odham Nation under Section 1 (b) of Article II of the Constitution of the Tohono O'odham Nation, and that their applications are approved, as herein above indicated.

BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the Tohono O'odham Nation reduce this final determination in writing regarding each of the foregoing applications for enrollment in accordance with Section 3 (c) of Article III of the Enrollment Ordinance; give notice of this Council's determination in accordance with
