

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval for Membership)

RES. NO. 348-87

1 WHEREAS, the Tohono O'odham Council has reviewed the applications of the
2 following individuals in accordance with Section 1 of Article VIII of
3 the Enrollment Ordinance, Ordinance No. 05-81, and has made a final
4 determination that the application of the following applicants for
5 membership in the Tohono O'odham Nation be approved:

6 ARTICLE II - MEMBERSHIP

7 SECTION (1b) ALL CHILDREN BORN TO RESIDENT MEMBERS

13 WHEREAS, the Tohono O'odham Legislative Council did hear testimony from

14 CECILIA HERNANDEZ
15 SUSIE ENOS
16 ISABEL FRANCISCO
17 JESSIE G. HERNANDEZ; and

18 WHEREAS, Cecilia Hernandez did testify that she should be given a district
19 regional reference by reason of descent from an ancestor on the base
20 roll and that they do intend and consider the Tohono O'odham Nation
21 their permanent home.

22 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that
23 the enrollment number of Cecilia Hernandez (Galvez) be amended to
24 reflect a regional reference of CK, including her children.


25 BE IT FURTHER RESOLVED that it is hereby determined that the above-named
26 applicants are eligible for enrollment as members of the Tohono
27 O'odham Nation under Section 1 (b) of Article II of the Constitution
28 of the Tohono O'odham Nation, and that their applications are
29 approved, as herein above indicated.

30 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
31 the Tohono O'odham Nation reduce this final determination in writing
32 regarding each of the foregoing applications for enrollment in ac-
cordance with Section 3 (c) of Article III of the Enrollment Ordi-
nance; give notice of this Council's determination in accordance with


1 Section 4 of Article III of the Enrollment Ordinance; and place the
2 names of each applicant upon the membership roll of the Tohono O'odham
3 Nation in accordance with Article V of the Enrollment Ordinance.

4 The foregoing resolution was passed by the Tohono O'odham Council on the 29th
5 day of September, 1987, at a meeting at which a quorum was present with a vote
6 of 1,453.0 for; -0- against; 187.0 not voting; and 01 absent, pursuant to the
7 powers vested in the Council by Section 1 of Article II and of Section 1 (h) of
8 Article VI of the Constitution of the Tohono O'odham Nation, adopted by the
9 Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy
10 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
11 Section 16 of the Act of June 18, 1934 (48 Stat. 984).


