1 WHEREAS, applications for enrollment as a member of the Tohono O'odham Nation
2 have been filed by or on behalf of:

5 GUTIERREZ, Irene ("Applicants")

6 WHEREAS, the Enrollment Committee has reviewed the application and has recom-
7 mended that the applications be denied because the applicants failed
8 to establish the following membership requirement(s): TOHONO O'ODHAM
9 CONSTITUTION, ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

10 WHEREAS, the applications have come on for hearing before this Council; and

11 WHEREAS, the Enrollment Committee did serve written notice of its recommen-
12 dation to reject the applications and of this hearing, as required by
13 Section 2, Article VI of the Enrollment Ordinance, upon the persons
14 who filed the applications and such persons were not present at this
15 hearing; and

17 WHEREAS, the Tohono O'odham Council has reviewed all of the evidence presented
18 and from such evidence finds that the applicants have failed to estab-
19 lish the foregoing membership requirement(s).

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does here-
21 by determine that the applications of:

25 for enrollment as members of the Tohono O'odham Nation are hereby

27 BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation shall
28 issue a certificate of Final Determination of Rejection and that the
29 Enrollment Committee serve Notice of Rejection of the applications in
30 accordance with the provisions of Section 1 and 2, Article VIII of
31 of the Enrollment Ordinance.


The foregoing resolution was defeated by the Tohono O'odham Council on the 29th day of September, 1987, at a meeting at which a quorum was present with a vote of 523.0 for; 631.0 against; 486.0 not voting; and 01 absent, pursuant to the powers vested in the Council by Article II and Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




