1 WHEREAS, applications for enrollment as a member of the Tohono O'odham Nation  
2 have been filed by or on behalf of:

8 WHEREAS, the Enrollment Committee has reviewed the applications and has recom-  
9 mended that the applications be denied because the applicants failed  
10 to establish the following membership requirement(s): TOHONO O'ODHAM  
11 CONSTITUTION, ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

12 WHEREAS, the applications has come on for hearing before this Council; and

13 WHEREAS, the Enrollment Committee did serve written notice of its recommen-  
14 dation to reject the applications and of this hearing, as required by  
15 Section 2, Article VI of the Enrollment Ordinance, upon the person who  
16 filed the application and such person was not present at this hearing;

18 WHEREAS, The Tohono O'odham Council has reviewed all of the evidence presented  
19 and from such evidence finds that the applicant has failed to estab-  
20 lish the foregoing membership requirement(s).

21 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does here-  
22 by determine that the applications of:



29 rejected.


30 BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation shall  
31 issue a certificate of Final Determination of Rejection and that the  
32 Enrollment Committee serve Notice of Rejection of the application in  
accordance with the provisions of Section 1 and 2, Article VIII of  
of the Enrollment Ordinance.

The foregoing resolution was defeated by the Tohono O'odham Council on the 29th day of September, 1987, at a meeting at which a quorum was present with a vote of 563.5 for; 621.0 against; 455.5 not voting; and -0- absent, pursuant to the powers vested in the Council by Article II and Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


