8 WHEREAS, the Enrollment Committee have reviewed the applications and has recom-
9 mended that the applications be denied because the applicants failed
10 to establish the following membership requirement(s): TOHONO O'ODHAM
11 CONSTITUTION, ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

12 WHEREAS, the applications have come on for hearing before this Council; and

13 WHEREAS, the Enrollment Committee did serve written notice of its recommen-
14 dation to reject the applications of this hearing, as required by
15 Section 2, Article VI of the Enrollment Ordinance, upon the persons
16 who filed these applications and such persons were not present at this
17 hearing; and

18 WHEREAS, the Tohono O'odham Council has reviewed all of the evidence presented
19 and from such evidence finds that the applicants did establish the
20 foregoing membership requirement(s).

21 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does here-
22 by determine that the applications of:

27 MORENO, MARTIN F.


28 for enrollment as members of the Tohono O'odham Nation are hereby
29 approved.

30 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
31 the Tohono O'odham Nation reduce this final determination in writing
32 regarding each of the foregoing applications for enrollment in ac-
cordance with Section 3 (c) of Article III of the Enrollment Ordi-


1 nance; give notice of this Council's determination in accordance with
2 Section 4 of Article III of the Enrollment Ordinance; and place the
3 names of each applicant upon the membership roll of the Tohono O'odham
4 Nation in accordance with Article V of the Enrollment Ordinance.

5 The foregoing resolution was passed by the Tohono O'odham Council on the 29th
6 day of September 1987, at a meeting at which a quorum was present with a vote
7 of 759.0 for; 362.5 against; 518.5 not voting; and -0- absent, pursuant to the
8 powers vested in the Council by Section 1 of Article II and of Section 1 (h) of
9 Article VI of the Constitution of the Tohono O'odham Nation, adopted by the
10 Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy
11 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
12 Section 16 of the Act of June 18, 1934 (48 Stat. 984).


