

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL
(Amending Council Agenda/Inviting Executive to Budget Review)

LEGIS. ORDER NO. 355-87

1 WHEREAS, it is the last day of the fiscal year FY '87, and the Nation does not
2 have a budget in place; and

3 WHEREAS, the Executive Office has voiced concerns regarding the FY '88 Budget
4 for the Nation; and

5 WHEREAS, a motion is made to continue discussing the Nation's budgets on
6 today's agenda.

7 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council amends its agenda
8 set for September 30, 1987 to continuing discussing the nation's
9 budgets.

10 BE IT FURTHER RESOLVED that the Legislative Council extends to the Executive
11 Office, the opportunity to be present and to share their concerns
12 regarding the FY '88 Budget for the Nation.

14 The foregoing order was passed by the Tohono O'odham Council on the 30th day of
15 September, 1987, at a meeting at which a quorum was present with a vote of
16 1,344.0 for; 105.5 against; 190.5 not voting; and 01 absent, pursuant to the
17 powers vested in the Council by Section 1 (a) of Article VI of the Constitu-
18 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
19 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
20 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
21 of June 18, 1934 (48 Stat. 984).
