(Adoption of Tohono O'Odham Nation's FY '88 Budgets)

1 WHEREAS, the Budget & Finance Committee did review and made a forecast of
2 projected revenues; and
3 WHEREAS, the Budget & Finance Committee did also make recommendations regarding
4 the FY '88 budgets for the Tohono O'Odham Nation; and
5 WHEREAS, the final recommendations to the Tohono O'Odham Legislative Council
6 were presented and are attached.
7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
8 hereby adopt the attached Tohono O'Odham Nation's budget in the amount
9 of \$5,598,500.00 and projected revenues at \$5,598,500.00

11 The foregoing resolution was passed by the Tohono O'odham Council on the 30th
12 day of September, 1987, at a meeting at which a quorum was present with a vote
13 of 978.0 for; 662.0 against; -0- not voting; and -0- absent, pursuant to the
14 powers vested in the Council by Section 1(d)(2)(3) of Article VI of the Constitu-
15 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
16 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
18 of June 18, 1934 (48 Stat. 984).




