5 Judges; and


6 WHEREAS, such statements are viewed as rumors; and

8 from the Legislative Chairperson a report regarding such rumors.


9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council

16 day of February, 1987, at a meeting at which a quorum was present with a vote
17 of 1418.5 for; -0- against; 221.5 not voting; and -0- absent, pursuant to the
18 powers vested in the Council by Section 1 (a) of Article VI of the Constitu-
19 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
