

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Budget recommended by the Budget & Finance Committee)

RES. NO. 362-87 DEFEAT


1 WHEREAS, a budget for the Tohono O'Odham Nation is not in place; and  
2 WHEREAS, the Tohono O'Odham Legislative Council, by Resolution No. 356-87,  
3 did adopt the Nation's budget in the amount of \$5,598,500.00 which was  
4 vetoed by the Tohono O'Odham Nation's Chairman; and  
5  
6 WHEREAS, it is necessary for the Nation to have a budget in place.  
7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does  
8 hereby give reconsideration to the total Budget recommended by the  
9 Budget & Finance Committee in the amount of \$5,598,500.00.  
10 The foregoing resolution was defeated by the Tohono O'odham Council on the 1st  
11 day of October, 1987, at a meeting at which a quorum was present with a vote of  
12 693.5 for; 776.0 against; 170.5 not voting; and 01 absent, pursuant to the  
13 powers vested in the Council by Section 1 (a) of Article VI of the Constitu-  
14 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
15 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
16 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
17 of June 18, 1934 (48 Stat. 984).
