
1 WHEREAS, the Budget for the Tohono O'Odham Nation, as adopted by Resolution No.
2 356-87, was vetoed; and

3 WHEREAS, it is necessary to address a budget for the Tohono O'Odham Nation.

4 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council will
5 place on today's agenda for consideration of a continuing resolution.


6 The foregoing resolution was passed by the Tohono O'odham Council on the 1st
7 day of October, 1987, at a meeting at which a quorum was present with a vote of
8 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers
9 vested in the Council by Section 1 (a) of Article VI of the Constitution of the
10 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
11 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
12 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
13 1934 (48 Stat. 984).
