4 WHEREAS, the current salaries of the Tohono O'Odham Legislative Council
5 Chairperson is \$30,001.20 and for the Tohono O'Odham Legislative
6 Council Vice Chairman is \$27,179.60.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
8 hereby approve the current salaries of the Tohono O'Odham Legislative
9 Council Chairperson at \$30,001.20 and \$27,179.60 for the Vice
10 Chairman.


12 The foregoing resolution was defeated by the Tohono O'odham Council on the 1st
13 day of October, 1987, at a meeting at which a quorum was present with a vote of
14 419.5 for; 880.5 against; 340.0 not voting; and 01 absent, pursuant to the
15 powers vested in the Council by Section 1 (d)(2)(3) of Article VI of the
16 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).




