

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY '88 Budget for the Tohono O'odham Nation's
Judicial Branch)

RES. NO. 367-87

1 WHEREAS, the Tohono O'odham Legislative Council did adopt Resolution No. 356-87
2 adopting FY '88 Tohono O'odham Nation's Budgets; and

3 WHEREAS, the Nation's Chairman Enos J. Francisco, Jr., did veto Resolution No.
4 356-87; and

5 WHEREAS, the Tohono O'odham Legislative Council did not override this veto; and

6 WHEREAS, the Budget and Finance Committee did recommend a budget of \$602,449.00
7 for the Tohono O'odham Nation's Judiciary.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does
9 hereby adopt the budget for the Tohono O'odham Nation's Judicial
10 Branch in the amount of \$602,449.


11 The foregoing resolution was passed by the Tohono O'odham Council on the 1st
12 day of October, 1987, at a meeting at which a quorum was present with a vote of
13 1,597.5 for; -0- against; 42.5 not voting; and 01 absent, pursuant to the
14 powers vested in the Council by Section 1 (d)(2)(3) of Article VI of the
15 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
16 on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
18 of June 18, 1934 (48 Stat. 984).
