3 WHEREAS, the Nation's Chairman Enos J. Francisco, Jr., did veto Resolution No.
4 356-87; and

6 WHEREAS, the Tohono O'odham Legislative Council failed to override the vetoed
7 Resolution No. 356-87; and

8 WHEREAS, the Budget and Finance Committee did submit and recommend to the
9 Legislative Council the following proposed FY '88 budgets for

30 '88 Budgets.

31 The foregoing resolution was passed by the Tohono O'odham Council on the 1st
32 day of October, 1987, at a meeting at which a quorum was present with a vote of
1,198.5 for; 185.0 against; 256.5 not voting; and 01 absent, pursuant to the
powers vested in the Council by Section 1 (d)(2)(3) of Article VI of the
Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).


