(Adopting the Tohono O'odham Nation's Chairman
and Vice Chairman's Salary)

RES. NO. 369-87

1 WHEREAS, the Tohono O'odham Legislative Council is in the process of adopting a
2 budget for FY '88; and

3 WHEREAS, the Nation's Chairman Enos J. Francisco, Jr., did veto Resolution No.
4 356-87; and

5 WHEREAS, the salary for the Tohono O'odham Nation's Officials must be set by
6 this Council.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
8 hereby sets the Tohono O'odham Nation's Chairman's salary at
9 \$33,944.00 and the Tohono O'odham Nation's Vice-Chairman's salary at
10 \$27,859.00.


12 The foregoing resolution was passed by the Tohono O'odham Council on the 1st
13 day of October, 1987, at a meeting at which a quorum was present with a vote of
14 755.0 for; 628.5 against; 256.5 not voting; and 01 absent, pursuant to the
15 powers vested in the Council by Section 4 of Article VII of the Constitution of
16 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
17 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).



5 either approve or disapprove it within 48 hours of submittal.


