

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Nation's Economic Development Fund)

RES. NO. 370-87

1 WHEREAS, the Tohono O'odham Legislative Council is in the process of adopting a
2 budget for FY '88; and

3 WHEREAS, there is a need to include monies to match the BIA Revolving Loan
4 Program.

5 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation's Budget shall
6 include a \$250,000.00 line item for Economic Development to be used as
7 matching funds for the BIA Revolving Loan Program.


8 The foregoing resolution was passed by the Tohono O'odham Council on the 1st
9 day of October, 1987, at a meeting at which a quorum was present with a vote of
10 908.0 for; 210.5 against; 521.5 not voting; and 01 absent, pursuant to the
11 powers vested in the Council by Section 1 (d)(2)(3) of Article VI of the
12 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
13 on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
14 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
15 of June 18, 1934 (48 Stat. 984).


