

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Executive Office FY '88 Budget)

RES. NO. 371-87

1 WHEREAS, the Legislative Council failed to override Resolution No. 356-87,

2 "Adopting the FY '88 Tohono O'odham Nation's Budgets" vetoed by the
3 Nation's Chairman; and

4 WHEREAS, the Tohono O'odham Legislative Council proceeded to review the
5 proposed FY '88 Executive Office Budget submitted by the Budget and
6 Finance Committee; and

7 WHEREAS, the Legislative Council agreed to approve the Executive Office budget
8 for FY '88 with the Chairman of the Nation's salary at \$33,944.00 and
9 the Vice Chairman at \$27,859.00.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
11 hereby adopts the FY '88 Budget of the Executive Office in the
12 amount of \$232,756.00.

13 BE IT FURTHER RESOLVED BY the Tohono O'odham Legislative Council that the
14 following items be deleted from the Executive FY '88 Budget:

16 -Director of Government Operations
17 -Staff Attorney
18 -Executive Aides (2).


19 The foregoing resolution was passed by the Tohono O'odham Council on the 1st
20 day of October, 1987, at a meeting at which a quorum was present with a vote of
21 1211.0 for; 312.0 against; 117.0 not voting; and 01 absent, pursuant to the
22 powers vested in the Council by Section 1 (d)(2)(3) of Article VI of the
23 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
24 on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
26 of June 18, 1934 (48 Stat. 984).



5 either approve or disapprove it within 48 hours of submittal.


