

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adoption of FY '88 Projected Revenues)

RES. NO. 372-87

1 WHEREAS, the Tohono O'Odham Legislative Council has proceeded to enact Budgets  
2 for the Tohono O'Odham Nation; and

3 WHEREAS, the Tohono O'Odham Legislative Council has acted on the Legislative,  
4 Executive and Judicial budgets; and

5 WHEREAS, it is necessary to project revenues which will be used to fund the  
6 Nation's budget.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation's projected  
8 revenues are hereby adopted in the amount of \$5,710,771.00 .


10 The foregoing resolution was passed by the Tohono O'odham Council on the 1st.  
11 day of October, 1987, at a meeting at which a quorum was present with a vote of  
12 1284.5 for; 355.5 against; -0- not voting; and 01 absent, pursuant to the  
13 powers vested in the Council by Section 1(d)(2)(3) of Article VI of the Constitu-  
14 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
15 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
16 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
17 of June 18, 1934 (48 Stat. 984).


