

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Agreement Implementing P.L. 99-469,
Tat Momolikot Dam Settlement Act)

RES. NO. 377-87

1 WHEREAS, the Tohono O'Odham Council has previously passed a resolution wherein
2 it approved a U.S. Congressional bill substantially in conformity with
3 the terms and conditions set forth in Public Law 99-469 (Tat Momolikot
4 Dam Settlement Act) which was enacted into law on October 14, 1986, a
5 copy of which is attached hereto and made a part of this Resolution;
6 and

8 WHEREAS, under the terms and conditions of Public Law 99-469, the Tohono
9 O'Odham Nation is entitled to receive certain benefits, including the
10 sum of six million dollars (\$6,000,000), plus interest, provided the
11 Nation, within one year from the enactment thereof, executes the
12 required waiver and release and a grant of the appropriate rights for
13 the Tat Momolikot Dam and reservoir; and

15 WHEREAS, attached hereto and made a part hereof, is an Agreement entitled,
16 "Agreement Between the United States and the Tohono O'Odham Nation to
17 Provide for the Implementation of the act of October 14, 1986", which
18 incorporates the substantive provisions of Public Law 99-469 and the
19 required grant, waiver and release; and

21 WHEREAS, the Sif Oidak District Council has by Resolution No. 12-87 approved
22 the attached Agreement and has requested that the Tohono O'Odham
23 Legislative Council approve and authorize the chairman to execute said
24 Agreement on behalf of the Nation; and

26 WHEREAS, the Legislative Council has reviewed the attached Agreement and
27 believes that it would be in the best interest of the Nation if the
28 Agreement is approved and executed.

30 NOW, THEREFORE BE IT RESOLVED that the Legislative Council does hereby
31 approve the Agreement entitled "Agreement Between the United States
32 and the Tohono O'Odham Nation to Provide for the Implementation of the
Act of October 14, 1986", and hereby authorizes and directs the
Chairman of the Nation to execute said Agreement, Grant of Easement

and other instruments incidental thereto on behalf of the Tohono
O'Odham Nation.

The foregoing resolution was passed by the Tohono O'odham Council on the 13th
day of October, 1987, at a meeting at which a quorum was present with a vote of
1581.5 for; 58.5 against; -0- not voting; and -0- absent, pursuant to the
powers vested in the Council by Section 1 (f) and (i) of Article VI of the
Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
