

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Library Services Grant Request)

RES. NO. 383-87

1 WHEREAS, the Education Department has provided library services to interested
2 persons, particularly to school aged children through its Library
3 Department, the Venito Garcia Library and extension libraries in
4 Pisinemo and San Xavier; and

5 WHEREAS, the Venito Garcia, Pisinemo and San Xavier Libraries provide services
6 in oral story-telling, recreational reading, cultural resources and
7 audio visual materials; and

8 WHEREAS, the funds appropriated for the expenses of the library are provided
9 through the Education Department's annual budget; and

10 WHEREAS, the Library Services Branch of the O'Odham Education Department is
11 submitting a proposal for a basic grant for library services from the
12 Department of Education, Washington, D.C.; and

13 WHEREAS, upon receipt of this basic grant the Tohono O'Odham Nation's Library
14 Services will be eligible for a special Library Services Grant.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that it does
16 hereby approve the proposal submitted to the U.S. Department of
17 Education, Office of Research and Improvement Library Programs for
18 funding of the Venito Garcia Library and the extension libraries in
19 Pisinemo and San Xavier.

22 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and the Treasurer of
23 the Tohono O'Odham Nation are hereby authorized to negotiate and
24 execute the grant and any amendments thereto for the duration of the
25 grant, provided however, that any amendments affecting the funding or
26 funding levels of the grant shall be submitted for further prior
27 approval by this Council.


29 The foregoing resolution was passed by the Tohono O'odham Council on the 13th

18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).


