

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing 2.5% COLA for Grant & Contracts
Program Budgets)

RES. NO. 384-87

1 WHEREAS, the Tohono O'Odham Nation's Legislative Council did review and pass FY
2 '88 Tribal Budgets which included a 2 1/2 Cost of Living Allowance;
3 and


4 WHEREAS, the FY '88 Grants and Contracts Program Budgets were subject to change
5 once a decision was made on the Cost of Living Allowance.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
8 it does authorize the Grants and Contracts Program Budgets to be
9 modified to include a 2 1/2 Cost of Living Allowance for FY '88.

10 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and the Treasurer of
11 the Tohono O'Odham Nation are hereby authorized to negotiate and
12 execute the grants or contracts and any amendments thereto for the
13 duration of the grants or contracts, provided however, that any
14 amendments affecting the funding or funding levels of the grants or
15 contracts shall be submitted for further prior approval by this
16 Council.


18 The foregoing resolution was passed by the Tohono O'odham Council on the 13th

20 1597.5 for; 42.5 against; -0- not voting; and 02 absent, pursuant to the powers
21 vested in the Council by Section 1 (d)(3)(f) of Article VI of the Constitution
22 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
23 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
24 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
25 June 18, 1934 (48 Stat. 984).


