
25 THEREFORE, BE IT RESOLVED that it is hereby determined that the above

29 are approved, as herein above indicated.

30 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of  
31 the Tohono O'odham Nation reduce this final determination in writing  
32 regarding each of the foregoing applications for enrollment in ac-  
cordance with Section 3 (c) of Article III of the Enrollment Ordi-  
nance; give notice of this Council's determination in accordance with


1 Section 4 of Article III of the Enrollment Ordinance; and place the  
2 names of each applicant upon the membership roll of the Tohono O'odham  
3 Nation in accordance with Article V of the Enrollment Ordinance.

4 The foregoing resolution was passed by the Tohono O'odham Council on the 14th  
5 day of October, 1987, at a meeting at which a quorum was present with a vote of  
6 1395.0 for; -0- against; 245.0 not voting; and 01 absent, pursuant to the  
7 powers vested in the Council by Section 1 of Article II and of Section 1 (h) of  
8 Article VI of the Constitution of the Tohono O'odham Nation, adopted by the  
9 Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy  
10 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to  
11 Section 16 of the Act of June 18, 1934 (48 Stat. 984).




