
1 WHEREAS, the following named person(s) have formally relinquished their


5 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does

11 day of October, 1987, at a meeting at which a quorum was present with a vote  
12 of 1317.5 for; 63.0 against; 259.5 not voting; and -0- absent, pursuant to the  
13 powers vested in the Council by Section 3 of Article II and Article VI Section  
14 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
