
1 WHEREAS, the Legislative Council on October 14, 1987, reviewed the contract
2 between the Tohono O'odham Nation TERO and Daniel S. Press, attorney;

6 contract and recommended the approval of the contract to the
7 Legislative Council.


8 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approve the con-
9 tract between the Tohono O'odham Nation TERO and Daniel S. Press,
10 Attorney.

11 The foregoing resolution was defeated by the Tohono O'odham Council on the 14th
12 day of October, 1987, at a meeting at which a quorum was present with a vote of
13 448.5 for; 1,063.0 against; 128.5 not voting; and -0- absent, pursuant to the
14 powers vested in the Council by Section 1 (f) of Article VI of the Constitu-
15 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
16 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
18 of June 18, 1934 (48 Stat. 984).


