(Amending Proposed Contract Between the Tohono O'odham Nation
TERO and Daniel S. Press, Attorney)


RES. NO. 391-87

1 WHEREAS, the TERO Program did submit a proposed contract between the Tohono
2 O'odham Nation TERO and Daniel S. Press, Attorney; and

4 WHEREAS, throughout the contract references are made to the Nation's Chairman
5 and Legislative Council which should be deleted.
6 NOW, THEREFORE, BE IT RESOLVED that the proposed contract shall be amended in
7 the following manner:


- 8 (1) Striking out #4 under A.,
- 9 (2) Striking out, in Section B, the reference made to the
10 Nation's Chairman or Legislative Council,
- 11 (3) In Section C replacing tribal official with TERO
12 Director.

13 The foregoing resolution was passed by the Tohono O'odham Council on the 14th
14 day of October, 1987, at a meeting at which a quorum was present with a vote of
15 756.0 for; 645.5 against; 238.5 not voting; and -0- absent, pursuant to the
16 powers vested in the Council by Section 2 (a) of Article VI of the Constitu-
17 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
18 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
20 of June 18, 1934 (48 Stat. 984).
