

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Rescinding Resolution No. 264-87 "Education Legal  
Counsel Contract")

RES. NO. 392-87

1 WHEREAS, on August 6, 1987 the Legislative Council, by Resolution No. 264-87  
2 agreed to contract with attorney Mark Ulmer on the terms provided in  
3 an education legal counsel contract dated July 21, 1987; and  
4  
5 WHEREAS, on August 17, 1987 Resolution No. 264-87 was submitted to the Chairman  
6 of the Tohono O'Odham Nation for approval or disapproval; and  
7  
8 WHEREAS, on August 21, 1987 the Chairman of the Tohono O'Odham Nation  
9 disapproved Resolution No. 264-87; and  
10  
11 WHEREAS, in its August 28, 1987 meeting and with the participation of the  
12 representatives of the Nation's Executive, the Human Resources  
13 Development Committee rewrote the proposed contract and by a unanimous  
14 vote recommended the rewritten version to the Domestic Affairs  
15 Committee; and  
16  
17 WHEREAS, the rewritten education legal counsel contract (dated 9/1/87) and  
18 hereafter called "Education Legal Counsel Contract" was reviewed and  
19 recommended for adoption by the Tohono O'Odham Legislative Council, in  
20 a meeting of the Domestic Affairs Committee on September 1, 1987. The  
21 recommended Education Legal Counsel Contract is attached to this  
22 Resolution and incorporated herein by reference; and  
23  
24 WHEREAS, signing of the Education Legal Counsel Contract pursuant to this  
25 Resolution does not appropriate or obligate any funds of the Tohono  
26 O'Odham Nation or its subdivisions for the purposes of the contract.  
27  
28 NOW, THEREFORE, BE IT RESOLVED that Resolution No. 264-87 is rescinded by the  
29 Legislative Council.  
30  
31 BE IT FURTHER RESOLVED that the Tohono O'Odham Nation agrees to contract with  
32 Mark Ulmer on the terms provided in the attached Education Legal  
Counsel Contract.  
BE IT FURTHER RESOLVED that Enos Francisco, Jr., Chairman is authorized to sign  
the Education Legal Counsel Contract on behalf of the Tohono O'Odham  
Nation and obtain the required approval of the Secretary of Interior.


1 The foregoing resolution was passed by the Tohono O'odham Council on the 14th  
2 day of October, 1987, at a meeting at which a quorum was present with a vote of  
3 1067.0 for; 190.0 against; 383.0 not voting; and 01 absent, pursuant to the  
4 powers vested in the Council by Section 2 (a) of Article VI of the Constitu-  
5 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
6 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
7 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
8 of June 18, 1934 (48 Stat. 984).


