RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Memorandum of Understanding between the Tohono O'Odham Nation and the Bureau of Reclamation)

RES. NO. 39-87

1 WHEREAS, there is a need for private employment for members of the Tohono 2 O'Odham Nation (Nation); and 3 WHEREAS, there will be significant employment opportunities for members of the 4 Nation on and off reservation on the construction of the Central 5 Arizona Project (CAP); and 6 WHEREAS, the Bureau of Reclamation indicated a willingness to require Indian 7 preference in employment on CAP contracts near the reservation in 8 9 return for the waiver of certain provisions of the TERO requirements 10 during on-reservation construction of CAP. 11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council 12 hereby approves the Memorandum of Agreement between the Nation and 13 the Bureau of Reclamation. 14 BE IT FURTHER RESOLVED that the Tohono O'Odham TERO shall report to the Tohono 15 O'Odham Legislative Council semi-annually on the number of members 16 17 of the Nation employed on CAP near-reservation projects and the total 18 amount of wages received by them. 19 The foregoing resolution was passed by the Tohono O'odham Council on the 3rd. day of February, 1987, at a meeting at which a quorum was present with a vote 20 of $\underline{1031.5}$ for; $\underline{184.5}$ against; $\underline{424.0}$ not voting; and $\underline{01}$ absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitu-21 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on 22 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act 23 of June 18, 1934 (48 Stat. 984). 24 TOHONO O'ODHAM LEGISLATIVE COUNCIL 25 26 27 Legislative Chairperson February, 1987. day of 28 29 ATTEST: 30
