

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Funding for three-day conference on Arizona Health Care
Cost Containment System)

RES. NO. 401-87

1 WHEREAS, the Tohono O'Odham Health Department, acting in the interest of the
2 Nation, desires to conduct a symposium on the Arizona Health Care Cost
3 Containment System (AHCCCS); and

4 WHEREAS, the conduct of such a symposium is in the critical interest of the
5 Tohono O'Odham Nation and all Indian Tribes within the State of
6 Arizona; and

7 WHEREAS, the symposium as it is to be conducted will serve to educate tribal
8 leaders within the State on issues of concern to Native Americans
9 eligible for services under AHCCCS, and further to educate Federal,
10 State and County governments on Native American concerns with respect
11 to AHCCCS; and

12 WHEREAS, such a symposium will enable tribal leaders within the State to
13 develop formal positions on the use of AHCCCS for providing health
14 care services to Native Americans, which can be used to support and
15 maintain appropriate health care services to Native Americans within
16 the State of Arizona.

17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does
18 firmly support the conduct of this symposium.

19 BE IT FURTHER RESOLVED that the Legislative Council hereby authorizes the use
20 of \$15,000.00 of contingency funds to cover the expenses of the
21 symposium. It is understood that the proceeds of the symposium
22 registration fees will be used to reimburse the Nation for the
23 development expenses incurred.

24 BE IT FURTHER RESOLVED that funds obtained from registrations in excess of the
25 \$15,000 grant or the actual amount of symposium development expenses
26 incurred shall be returned to the Tohono O'Odham Health Department in
27 a Health Education and Development account to be used to support
28 similar projects and the delivery of special services.

2 day of November, 1987, at a meeting at which a quorum was present with a vote
3 of 1339.0 for; 184.0 against; -0- not voting; and 117.0 absent, pursuant to the
4 powers vested in the Council by Section 1 (d) of Article VI of the Constitu-
5 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
6 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
7 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
8 of June 18, 1934 (48 Stat. 984).
