 Containment System (AHCCCS); and

 WHEREAS, the conduct of such a symposium is in the critical interest of the

 Tohono O'Odham Nation and all Indian Tribes within the State of

 Arizona; and
 - WHEREAS, the symposium as it is to be conducted will serve to educate tribal leaders within the State on issues of concern to Native Americans eligible for services under AHCCCS, and further to educate Federal, State and County governments on Native American concerns with respect to AHCCCS; and

- WHEREAS, such a symposium will enable tribal leaders within the State to develop formal positions on the use of AHCCCS for providing health care services to Native Americans, which can be used to support and maintain appropriate health care services to Native Americans within the State of Arizona.
- NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does firmly support the conduct of this symposium.
- BE IT FURTHER RESOLVED that the Legislative Council hereby authorizes the use of \$15,000.00 of contingency funds to cover the expenses of the symposium. It is understood that the proceeds of the symposium registration fees will be used to reimburse the Nation for the development expenses incurred.
- BE IT FURTHER RESOLVED that funds obtained from registrations in excess of the \$15,000 grant or the actual amount of symposium development expenses incurred shall be returned to the Tohono O'Odham Health Department in a Health Education and Development account to be used to support similar projects and the delivery of special services.
