WHEREAS, the Budget & Finance Committee of the Tohono O'Odham Legislative

Council has reviewed the investments by the Nation of its general fund

cash reserves and has determined that the Nation may be best served by

the employment of a professional investment management company in the

investment of its cash reserves; and

WHEREAS, the Harris Trust Company of Arizona has offered its investment

management services to help the Nation invest cash reserves available

for such purposes in its general fund; and

WHEREAS, the Legislative Council believes that the Nation may be best served if it employs or uses the services of a professional investment management company in the investment of the cash reserves.

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby authorize and direct the Budget & Finance Committee to develop an investment policy and to meet with the Harris Trust Company and their investment managers in order to prepare for Council consideration and action, legislative authorization and direction for the investment of the Nation's general fund cash reserves.

The foregoing resolution was passed by the Tohono O'odham Council on the $\frac{4\text{th}}{4\text{th}}$ day of November, 1987, at a meeting at which a quorum was present with a vote of $\frac{1459.5}{120.5}$ for; $\frac{-0}{120.5}$ against; $\frac{180.5}{120.5}$ not voting; and $\frac{-0}{120.5}$ absent, pursuant to the powers vested in the Council by Section 1 (d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
