11	Committee.

13	day of November, 1987, at a meeting at which a quorum was present with a vote of 296.5 for; 1,174.5 against; 169.0 not voting; and 01 absent, pursuant to the
14	powers vested in the Council by Section 1 (c) of Article VI of the Constitu- tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
15	January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
