
1 WHEREAS, Patrick Whillock has applied for a permit to buy livestock on the
2 Tohono O'Odham Nation; and

3 WHEREAS, the Tohono O'Odham Council has found that he is in every way qualified
4 for the issuance of a Livestock Buyer's Permit.


5 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it hereby
6 approves the issuance of a Livestock Buyer's Permit to Patrick
7 Whillock pursuant to the provisions of the Tohono O'Odham Nation and
8 Federal Law.

10 The foregoing resolution was passed by the Tohono O'odham Council on the 5th
11 day of November, 1987, at a meeting at which a quorum was present with a vote
12 of 1581.5 for; 58.5 against; -0- not voting; and 01 absent, pursuant to the
13 powers vested in the Council by Section 1 (c)(1) and (d)(4) of Article VI of
14 the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham
15 Nation on January 18, 1986, and approved by the Acting Deputy Assistant
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
17 16 of the Act of June 18, 1934 (48 Stat. 984).


