NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it hereby approves the issuance of a Livestock Buyer's Permit to Patrick Whillock pursuant to the provisions of the Tohono O'Odham Nation and Federal Law.

The foregoing resolution was passed by the Tohono O'odham Council on the $\underline{5th}$ day of November, $\underline{1987}$, at a meeting at which a quorum was present with a vote of $\underline{1581.5}$ for; $\underline{58.5}$ against; $\underline{-0}$ not voting; and $\underline{01}$ absent, pursuant to the powers vested in the Council by Section 1 (c)(1) and (d)(4) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
