

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Renegotiation of the El Paso Natural Gas Right-of-Way)

RES. NO. 407-87

1 WHEREAS, the Grant of Easement for Right-of-Way for El Paso Natural Gas was
2 executed on October 17, 1977, by Resolution No. 57-77 of the Papago
3 Council; and


4 WHEREAS, the Easement provides for the review and renegotiations after the ten
5 (10) year period, in order to make adjustments and pay for any
6 increase in the fair market value of the rights granted; and

7 WHEREAS, the Sif Oidak District Council and the Hicikiwan District Council
8 recommends the utilization of the Consumer Price Index method as a
9 means of renegotiation.



11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
12 hereby directs the appropriate authorities of the Tohono O'odham
13 Nation to use the Consumer Price Index as the formula for adjusting
14 the fair market value of the rights granted in the easement in the
15 renegotiations.

16 The foregoing resolution was passed by the Tohono O'odham Council on the 5th
17 day of November, 1987, at a meeting at which a quorum was present with a vote
18 of 1,073.0 for; 221.0 against; 346.0 not voting; and 01 absent, pursuant to the
19 powers vested in the Council by Section 1 (i)(1) of Article VI of the Constitu-
20 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
21 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
23 of June 18, 1934 (48 Stat. 984).
